

Advancing Student Independence with Innovative Tools


Communicating with Confidence

The William G. and Helen C. Hoffman Foundation provided support for students' communication and educational development through the purchase of two eye-gaze systems with corresponding software and technologies. Since October 2024, fourteen students have received therapy sessions utilizing the latest technology to achieve their Individualized Education Plan goals. Student successes include using the system to create Christmas lists.



Starting Strong with Speech

In the School's Early Intervention (EI) program, therapists use "Ready, Set, Go Kits" with an array of Augmentative and Alternative Communication (AAC) tools to help determine how best to support a child's communication needs. AAC tools include image-based communication books, switches, and iPads. As the EI program continues to see an increase in referrals for children with significant delays in communication, grant funding from [The Arnold A. Schwartz Foundation](#) plays a critical role in expanding our AAC services.



Building Skills Through Adaptive Play


A grant from [The Morristown Rotary Club](#) helped P.G. Chambers School address a key challenge for our students: accessing meaningful play and social experiences. By purchasing and integrating adaptive technology like Cosmo switches into daily use, we can provide our students with interactive and developmentally appropriate activities that promote socialization and skill-building.

3D Printing, Real-World Change

3D printing technology is a powerful tool for creating adaptive devices tailored to the needs of children with disabilities. Thanks to [The Union Foundation](#), the assistive technology team has purchased a 3D printer and creates personalized assistive tools that improve our students' participation in learning.

Unlocking Potential Through Power Mobility

Many students face significant motor challenges and have limited ability to move independently. In response, our award-winning Power Mobility program empowers students with self-initiated movement for exploration and learning, encourages physical development, and supports both equipment evaluation and skill-building. A generous grant funded by [The ADP Foundation](#) supports therapist time for student evaluations, hands-on training, and program management.



Upgrading Facilities for Safety and Functionality

Supporting Our Youngest Learners

The Summit Foundation provided a grant to enhance participation and ensure safety for preschool students through the purchase of adaptive seating, desks, and standers. Adaptive seating and positioning systems provide safe support, promote trunk and head control, and help improve a child's posture and functional use of their arms and head. In addition, mobile standers and sit-to-stand desks help our students build greater independence and improve their mobility.



Enhancing Access to Literacy and Therapy

P.G. Chambers School created a dedicated space for occupational and speech therapy literacy activities, giving these services the focused environment they need to thrive thanks to grant funding from [The ADP Foundation](#). The new literacy space features assistive technologies such as eye-gaze systems and guided hands technology. Eye-gaze systems support communication for students with physical and verbal challenges, while guided hands technology supports drawing and writing.

Ensuring Safe, Dignified Care

Thanks to generous support from [The Dorothy B. Hersh Foundation](#), we are continuing to provide a safe and supportive environment for our students, where their hygiene needs are met with timeliness and respect. We installed ceiling mounted lift systems in the three student bathrooms that serve our older, larger students. This has improved the student transfer process from wheelchair to changing table and/or to toilet, eliminating bathroom delays and reducing staff exertion and back strain.



Refreshing Our Spaces

To ensure a safe, welcoming, and functional environment for every child, staff member, and visitor, P.G. Chambers School sought essential support from [The Hyde and Watson Foundation](#). The capital improvement project replaced carpeting on our second floor - part of a broader project that includes flooring repair and replacement in our older classrooms.



Advancing Staff Expertise to Meet Complex Student Needs



Natasha Kirk became the first Nationally Certified DeafBlind Intervener in New Jersey, recognized by the National Resource Center for Paraeducators, Related Service Providers and Interveners.

At leading assistive technology conference ATIA, staff showcased innovative work: **Tracie Murray** and **Ashley Rivera** presented “Are Your Students Ready to Learn? Steps for a Power Mobility Initiative,” while **Dana Hall** and **Jen Jacobs** presented “Learning Nutrition and Building Friendships through Accessible Cooking.”

In literacy and technology, **Carol Barron** earned Orton-Gillingham Classroom Educator certification, and **Cassie Lago** achieved Assistive Technology Professional certification. Speech language pathologists **Sam Ayala**, **Lauren Duffy**, and **Christine Ingilizyan** completed a 15-week AAC Advanced Training Course at Stockton University, deepening their skills to better support students with complex communication needs.

Recognizing Excellence in Education and Therapy

ASAHI, serving New Jersey’s private special education community, honored two staff with statewide awards: **Juliana Menniti**, Early Childhood/Elementary School Teacher of the Year, and **Ashley Rivera**, Physical & Sensory Support Services Professional of the Year.

We also celebrate our nominees: **Laura Jaarsma**, Middle School Teacher; **Candice Iszard**, Preschool-5th Grade Paraprofessional; **Luz Amaya**, Middle School Paraprofessional; **Dana Hall**, Communication & Assistive Technology Services Professional; and **Allison Yakush**, Social Emotional & Health Support Services Professional.





Sports, Theater, and Music Bring Learning to Life


Our students show us every day what's possible when learning comes to life.

At P.G. Chambers School, our students discover confidence, creativity, and connection through hands-on activities that celebrate learning, movement, and the arts. This year, our students shined both on the field and the stage!

Students brought Olympic spirit to School during the [2024 Summer Olympics](#), participating in opening and closing ceremonies, water games, track and field races, and volleyball matches. Our youngest children also joined the [Special Olympics Young Athletes Day](#), where they practiced skills like kicking and throwing.

A 10-week residency with the Millburn, NJ-based [Paper Mill Playhouse](#) introduced acting and storytelling into our classrooms. Students explored artistic expression as they learned to bring stories like *Sleeping Beauty* to life.

Weeks later, students experienced the wondrous beauty of live music through a residency with the [New Jersey Symphony](#), where violin, viola, and cello performances filled the School with joy.



During the New Jersey Symphony residency, students had opportunities to see, hear, and interact with string instruments as they moved along to classics like "If You're Happy and You Know it" and Joplin's "The Entertainer."

The Heart of Giving

On October 6, 2024, nearly 300 walkers, runners, and rollers joined P.G. Chambers School for the **Walk.Run.Roll.** and family carnival. The event helped to raise over \$39,000 for exceptional special education, early intervention, and therapy programs that serve the children of P.G. Chambers School.

The **Menus for the Mind** evening gala, hosted at the Park Avenue Club on April 10, 2025, raised more than \$315,000 to support our children's mobility, communication, and educational needs. The evening honored trustee emerita **Lori Solomon** for her extraordinary dedication to the School over the past two decades and featured inspiring remarks from award-winning photographer **Rick Guidotti** of Positive Exposure, who reminded us that beauty is found in every individual.

Also in 2025, the **Golf Classic** celebrated its 20th year of bringing together a dedicated community of golfers who raised over \$90,000 for the School's exceptional education and therapy services. The event was held at the Rockaway River Country Club, and the tournament sponsor was The Charles F. and Ruth J. Knippenberg Foundation.

Altogether, fundraising from our special events programming helps to provide new technologies, curriculum, specialized equipment, and materials to our students.


In the 2024/2025 school year, your financial support helped P.G. Chambers School provide education and therapy services to 824 children across eleven counties in northern New Jersey.

Summary of Financial Performance


2024/2025 Funds Raised


2024/2025 Operating Revenue




